The main challenge is to transform temporarily limited collective actions towards collective continuity in order to oppose everyday suppression and injustice. The artistic works developed by students of the Vienna University of Applied Arts in the course of the project Balkan Refugee Trail - A Pathway for European Solidarity could be described as observations which approach processes around solidarity and solidary action from a personal perspective through artistic media. What
	part did the media play in the following months? In television, recurrent scenes recorded with respectively longer focal length conveyed the impression of threatening masses straight into the citizens' living rooms. Due to the asymmetry of power between the representatives of national states and civil society, the voices of solidarity become drowned in the roar for isolation and new boundaries.
